Description	The Devereux Early Childhood Assessment for Infants (DECA-I) is a behavior rating scale that is completed by parents and/or caregivers which provides an assessment of within-child protective factors central to social and emotional health and resilience in infants ages 4 weeks up to 18 months. The DECA-I is part of the Devereux Early Childhood Assessment Program for Infants and Toddlers (DECA-I/T) which includes the Devereux Early Childhood Assessment for Toddlers (DECA-T), an assessment for toddlers 18 months to 36 months.

Raters	Raters fall into two categories: 1) parents, guardians, other family caregivers or family child care providers who observe the child in a homelike setting; and 2) teachers or other childcare and education professionals who see the child in a child care program or infant toddler program. Observation of the infant over a 4 week period is necessary to complete the assessment. No specific training required to rate the child.

Total Protective Factor (TPF) coefficients for Parent raters on the Infant Form range from .90 - .94; and coefficients for teacher raters ranged from .93 - .94. These figures meet or exceed the recommended minimum standard—See User’s Manual for details.</p> <p>Test-retest reliability – Significant at the $p < .001$ level. DECA-I coefficients for parent raters across scales range from (.86 - .94) and teacher raters (.83 - .84). These figures meet or exceed the recommended minimum standard.</p> <p>Inter-rater reliability – High and Significant at the $p < .01$ level. Total Protective Factors coefficient was .68 for parent raters and .72 for teacher raters.</p> <p>Validity:</p> <p>Content validity – High, based on literature review of resilience literature related to young children, focus groups with parents, teachers, and infant and early childhood mental health professionals, as well as careful review of other infant and toddler social and emotional assessments.
